The Katara Beach has issued the following Basic Rules and Regulations in accordance with its approved policies and safety standards.

- 1. It is the obligation of each member to adhere to the Rules and Regulations of Katara Beach. Failure to do so may result in immediate cancellation of the Membership without refund.
- The Membership application and its renewal are subject to approval by the Management of Katara Beach.
 The non-acceptance of a membership application or non-renewal of an existing membership will not warrant any form of explanation.
- 3. Membership of the Katara Beach is either twelve months (12) or six months (6) from the date of joining.
- 4. Applicants are required to accurately fill in the application form. Applicants are accountable for the legitimacy of the information, they provide. Once the application is approved, it is the obligation of each member to communicate to the Membership Coordinator any significant update to their details or any changes to the member's status.
- 5. Membership fees and rates of other products and services of the Katara Beach remain subject to variations decided upon by the Management. Members will be advised of the prevailing rates accordingly.
- 6. The Membership fee doesn't entitle the member to free use of the Water Sports facilities. Separate fees shall apply for each Water Sport Activity.
- 7. Applicants are required to provide all other supporting documents as required by the Katara Beach.
- 8. Subsequent to the approval of the application, the newly selected member shall receive a customized Membership Card. This card remains the property of Katara Beach and shall be immediately returned upon the termination of membership.
- 9. Family membership is available to families with children aged 16 years old and below.
- 10. Single membership is available only for persons of above 16 years.
- 11. Membership is neither transferable nor refundable under any circumstances.
- 12. Loss of a membership card has to be reported immediately to the Katara Beach. A prevailing charge will be imposed for the replacement of the card.
- 13. Use of the membership card by any person other than the cardholder may result in cancellation of the membership. A daily rate will be charged for nannies and baby sitters and they have to abide by the rules and regulations of Katara Beach. Drivers are not allowed onto the beach.
- 14. Nannies/Baby sitters are not allowed to use the facilities at Katara Beach.
- 15. Valid membership cards must be presented every time at the check-in point of the Katara Beach upon arrival and prior to using any of the Beach facilities.
- 16. The checked-in members shall receive and wear at all times an approved wrist band as provided by Alyazwa while on the Katara Beach premises.
- 17. A Family Membership is entitled to have two umbrellas and eight beach chairs per check-in.
- 18. The Katara Beach reserves the right to suspend any member or guest from its premises for reasons related to misbehavior or misconduct.
- 19. Appropriate swimming suits must be worn when using any of the Beach's facilities. Revealing or inappropriate clothing will not be accepted on any of The Katara Beach premises.
- 20. Members are liable for property damaged or destroyed by themselves or by their guests.
- 21. Parents are responsible at all times for the safety and for the behavior of their children. All children below the age of 16 y/o must be accompanied by a responsible adult member of 17 years old or above.
- 22. Members are not allowed to bring any food/beverages on the beach unless it is for a pre-determined medical condition or for feeding babies or children up to 4 years old.
- 23. It is forbidden to take any item belonging to the Katara Beach out of the Beach's premises.
- 24. Any activities considered by the Beach staff as disturbing or dangerous to others will not be accepted. Non-compliance with staff instructions on this matter could lead to membership cancellation.
- 25. Members should take into consideration that some areas of the facility are mixed (for both Ladies & Gents). Decent and respectful behavior is expected from all persons using the club's facilities, at all times.
- 26. Photographs and video taking is strictly prohibited on the Katara Beach premises, as well as playing loud music.
- 27. Katara Beach will not be liable for any injury to or the death of any person, loss of or damage to property, appertaining to the existence, conditions or use of the club's facilities by the members or their guests. Any person entering the Beach and using its facilities do so at their own risk. Katara Beach Management does not accept any responsibility for any loss, theft or damage caused to any items, valuables or any other personal belongings of persons using the Beach's facilities.
- 28. The Management reserves the right to alter the Beach's hours of operation when necessary without prior notice.
- 29. Members must be aware of all related swimming and water safety signage and should follow the instructions of beach lifeguards at all times.
- 30. Katara Beach Management reserves the right to amend the Rules and Regulations with or without prior notice.
